

FEDERAL ACQUISITION REGULATION (FAR) AND DEPARTMENT OF DEFENSE FEDERAL ACQUISITION REGULATION (DFAR) CLAUSES UNDER NRL PRIME CONTRACT N00173-15-F-6702

The FAR and DFAR clauses referenced below are incorporated herein and made a part of this Subcontract Agreement. In all clauses, unless the context of the clause requires otherwise, the term “Contractor” shall mean Subcontractor, the term “Contract” shall mean this Subcontract, and the terms “Government”, “Contracting Officer” and equivalent phrases shall mean Contractor and Contractor’s Subcontracting Representative, respectively. It is intended that the referenced clauses shall apply to Subcontractor in such manner as is necessary to reflect the position of Subcontractor as a Subcontractor to Praxis, to insure Subcontractor’s obligations to Praxis and to the United States Government, and to enable Praxis to meet its obligations under its Prime Contract.

Additionally, whether or not incorporated by reference herein, in accordance with Praxis’s OASIS SB contract, under which Prime Task Order N00173-15-F-6702 was awarded, all applicable and required provisions/clauses set forth in FAR 52.301 automatically flow down to this subcontract, based on their specific contract type (e.g. cost, fixed price, etc.), statement of work, competition requirements, commercial or not commercial, and dollar value.

If a clause is not applicable under the Subcontract it shall be considered self-deleting.
